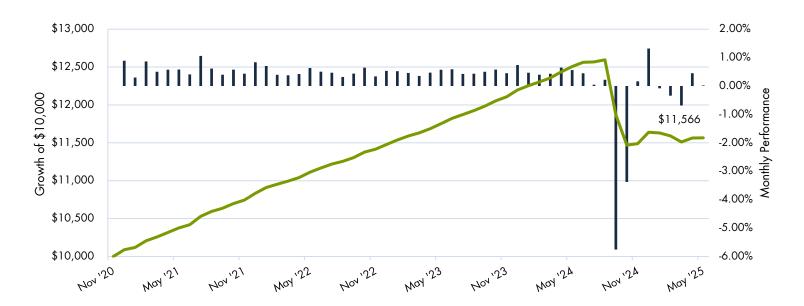

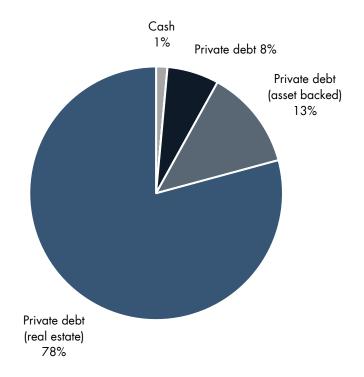

#### **EXPOSURE & STRATEGIES**

Geographic exposure can be difficult to quantify at any one time in the Pool due to sub-advised strategies, but currently there is approximately 99% exposure to USA, 1% to Canada, and 0% to the global markets.
